

Annex to the NCN Council Resolution No 86/2018 of 28 September 2018

Terms and regulations on awarding funding for research tasks funded or co-funded under international calls BiodivERsA Call 2018 and QuantERA Call 2019 launched by the National Science Centre and carried out as multilateral collaboration

Chapter I General provisions

§ 1. This Resolution lays down the terms and conditions of awarding funding for the research tasks to be carried out by Polish research teams in the projects submitted as proposals to international calls BiodivERsA Call 2018 and QuantERA Call 2019 launched by the National Science Centre and carried out as multilateral cooperation, hereinafter referred to as "international calls."

§ 2. Awarding funding for research tasks carried out by foreign research teams is governed by rules adopted by the agencies co-organising the international call.

§ 3. The amount of funding allocated for the implementation of research tasks funded by the National Science Centre (NCN) under international calls are set out by the NCN Council. In individual cases, the Council may increase the funding earmarked for a given call.

§ 4. Detailed terms of international calls for proposals are governed in each case by separate documents approved by the agencies launching a given call.

Chapter II

International calls: eligible applicants

§ 5. Proposals requesting funding of research projects under international calls may be submitted by the entities referred to in Article 27 (1) (1–7 and 9) of the Act on the National Science Centre of 30 April 2010 (Journal of Laws of 2018, item 947, as amended), in which research projects will be carried out by Polish research teams, i.e.:

- 1) entities referred to in Article 7 (1) (1, 2 and 4 8) of the Act on Higher Education and Science of 20 July 2018 (Journal of Laws of 2018, Item 1668);
- 2) groups of entities including at least two entities referred to in point 1 or at least one of those entities and at least one enterprise;
- 3) science and technology facilities as defined in the Act on Research Institutes of 30 April 2010 (Journal of Laws of 2018, Item 736, as amended);
- 4) research centres of the Polish Academy of Sciences as defined in the Act on the Polish Academy of Sciences (Journal of Laws of 2018, item 1475, as amended);
- 5) scientific libraries;
- enterprises established as research and development centres as defined in the Act on Certain Forms of Support for Innovative Activities of 30 May 2008 (Journal of Laws of 2018, items 141 and 1669);
- 7) legal entities established in the territory of the Republic of Poland;
- 8) enterprises conducting research and established in organisational forms different from the forms defined in points 1–7,

hereinafter referred to as the "applicants"



Chapter III International calls: terms of entry

- § 6. Under international calls proposals may be submitted for funding of research projects:
 - which constitute basic research within the meaning of Article 4 (2) (1) of the Act on Higher Education and Science of 20 July 2018, in any of the disciplines specified by the NCN's panels, as adopted by the NCN Council Resolution No 102/2016 of 10 November 2016;
 - 2) whose principal investigators hold at least a doctorate;
 - 3) whose duration is 24, 36, 48 or 60 months, with the reservation that it may not exceed the maximum duration of the project laid down in the documentation approved by the agencies launching a given international call;
 - 4) in which the requested costs comply with the rules set out in **annex 1** to this document, concerning the costs in research projects funded or co-funded under international calls launched by the NCN.

Chapter IV Submission of proposals

§ 7. Applicants requesting funding or co-funding of research projects from the NCN under international calls submit a joint proposal together with their foreign partners, in accordance with a procedure approved by the agencies launching a given international call.

§ 8. A joint proposal referred to in §7 may only be annexed to one proposal submitted to the NCN.

§ 9. In the case of applicants referred to in §5 (2), the proposal to the NCN is submitted by a leader specified in the agreement on collaboration concluded by a group of entities for the purposes of joint completion of the requested research project. The leader of the group of entities is the institution employing the principal investigator. Each entity included in the group of entities has a separate budget, however the cap on the total funds for remuneration referred to in point 2 (1) of **annex 1** to this document applies jointly to the entire group of entities.

§ 10. In a one-stage call¹, the applicants submit preliminary proposals to the NCN no later than on the final day of the international call for proposals. In a two-stage call², the preliminary proposal should be submitted only in the second stage, no later than on the final day of the call for international full proposals.

§ 11. The applicants submit the so-called preliminary NCN proposals in an electronic form via the ZSUN/OSF (Zintegrowany System Usług dla Nauki /Obsługa Strumieni Finansowania) proposal submission system at <u>www.osf.opi.org.pl</u>, in accordance with the data required, set out in **annex 2** to this document.

§ 12. The applicants whose projects have been recommended for funding submit the so-called complementary NCN proposals, in accordance with the data required, set out in **annex 2** to this document.

¹ In a one-stage call the applicants submit only a full proposal.

² In a two-stage call the applicants first submit a joint *pre-* or *outline proposal*, and if successful, in the second stage they submit a *full proposal*.



- § 13. The applicant referred to in § 12 is required to:
 - 1) fill out a complementary NCN proposal and annexes thereto in the ZSUN/OSF system, in accordance with the data required, set out in **annex 2** to this document;
 - submit a complete proposal together with the required annexes electronically via the ZSUN/OSF system, together with a confirmation of proposal submission bearing a qualified electronic signature or the document's scan with the signature in the signatory's own handwriting³.

§ 14. Complementary proposals must be submitted to the NCN within 30 days after the receipt of the information on the results of the international call.

§ 15. The NCN accepts only proposals that are complete and meet the terms of an international call adopted by the agencies launching a given call and the terms set out in chapters II and III of this document.

Chapter V

Evaluation of proposals of research projects

§ 16. Preliminary and complementary proposals are subject to eligibility checks and meritbased evaluation.

§ 17. The eligibility check of proposals submitted under the procedure referred to in chapter IV is carried out by NCN Coordinators.

- § 18. Proposals may be rejected as ineligible also at a later stage of the evaluation procedure.
- § 19. Eligibility check consists in:
 - 1) evaluation of whether the proposal complies with the terms of an international call and the terms set out in chapter III;
 - evaluation of whether the requested costs stated in the joint proposal and the complementary NCN proposal comply with the terms governing the costs in research projects funded or co-funded under international calls launched by the NCN, set out in annex 1 to this document.

§ 20. Should any doubts arise concerning the eligibility check, an NCN Coordinator may apply to the NCN Director for the consultation of an external expert.

§ 21. The merit-based evaluation is open only to research proposals evaluated positively at the stage of the eligibility check.

§ 22. The terms of the merit-based evaluation of proposals for funding of research projects, including the mode, criteria of selecting expert reviewers and the measures for ensuring impartiality of the entire process are in each case laid down by separate documents approved by the agencies launching a given international call.

§ 23. An NCN Coordinator presents for the NCN Director's approval a ranking list of projects to be conducted in collaboration with Polish research teams, which were recommended for funding in the final international ranking list agreed by the agencies co-organising an international call.

Chapter VI

Mode of funding

§ 24. Funds for the completion of research projects carried out by the Polish applicants

recommended for funding are awarded by way of a decision of the NCN Director (subject to § 3), unless otherwise provided in the separate regulations for a given call. Funds for tasks carried out by foreign partners are granted according to the rules agreed by the agencies co-organising an international call.

§ 25. Funds for the applicants classified as enterprises are granted pursuant to the Regulation of the Minister of Science and Higher Education of 9 September 2015 on the terms and mode of granting state aid via the National Science Centre (Journal of Laws of 2015, item 1381).

§ 26. The funds are transferred to the applicant host institution and in the case of a group of entities, to the leader of the group, pursuant to a funding agreement concluded between the NCN, the host institution and the principal investigator of the Polish research team.

§ 27. Within the deadline specified in the decision, the applicant is obliged to submit to the NCN a draft funding agreement, including the project's work plan and breakdown of costs, and to perform other actions ordered in the decision. Failure to meet the deadline is equivalent to resignation from concluding the funding agreement.

§ 28. Appeals (if any) will be addressed and decided upon by the agencies launching a given international call.

TYPES OF COSTS IN RESEARCH PROJECTS FUNDED BY THE NATIONAL SCIENCE CENTRE UNDER INTERNATIONAL CALLS BIODIVERSA CALL 2018 AND QUANTERA CALL 2019 CARRIED OUT AS MULTILATERAL COOPERATION

<u>ELIGIBLE COSTS</u> are expenditures eligible for funding from NCN resources and fulfilling all of the following criteria:

- 1) they are critical to the completion of the project,
- 2) they have been incurred from the day on which the funding decision of the NCN Director became legally binding until the final date of the research project's implementation⁴,
- 3) they are incurred in line with the principle of advisability and frugality, and in line with the principle of obtaining optimal effects from given resources,
- 4) they allow for identification, are verifiable and scrupulously documented and duly recorded in an account book,
- 5) they conform with applicable rules and regulations, including the rules and regulations of the host institution and the rules and regulations of the NCN, including the rules set forth in this document.

The following shall not be deemed eligible costs:

- costs of visits and consultations by collaborators from foreign research institutions, who receive separate funding for the project from the agencies co-organising the international call for proposals,
- reserves for future liabilities, interest due and other expenditures for debt-servicing, interest and other expenditures for late payments, contractual penalties, fines, penalties and payments for the costs of judicial proceedings,
- 3) VAT, if the host institution is entitled to reclaim VAT,
- 4) costs of proceedings related to conferment of academic degrees/titles,
- 5) costs of fees paid for pre-publishing reviews.

The eligibility of costs is assessed during the proposal evaluation, evaluation of the annual report, evaluation of the final report, review of the project and during the external audit.

Eligible costs incurred by the host institution are subdivided into direct and indirect costs.

1. Indirect costs are the costs related indirectly to the research project, and essential for the proper realisation of the funding agreement.

The maximum limit for indirect costs is 40 per cent of direct costs, excluding "costs of research equipment, devices and software."

⁴ If the funding agreement is not signed for reasons attributable to the applicant host institution or principal investigator, reimbursement of the costs incurred cannot be demanded of the NCN. Making records of costs and settling all liabilities accrued during the project implementation is possible by the date of submitting the final report, no later, however, than within 60 days of the research project end date.



Indirect costs shall be covered by a lump sum and considered as incurred expenditure. The host institution shall arrange with the project's principal investigator for the distribution of at least 25 per cent of the indirect costs' value.

2. <u>Direct costs</u> are costs directly related to the completion of the research project; the following direct costs may be distinguished:

- costs of the salaries and NCN scholarships,

- costs of research equipment, devices and software,
- other direct costs.

The following expenditures may not be covered from direct costs:

- 1) salaries of the administrative and financial staff (performing services related to personnel, accounting, legal issues, including the outsourcing of accounting to an accountancy office),
- 2) costs of renovation of facilities,
- 3) costs of adapting/upgrading facilities, so that they can meet the needs of the research tasks,
- 4) fees and rent for the use of facilities, property taxes, etc.,
- 5) utilities (cost of electricity, heating, heating gas, water, as well as other transmission fees, sewage, etc.), telecommunications charges (telephone, Internet) and mail and courier services, excluding the services referred to in point 2.3.2.
- 6) costs of cleaning, janitorial and security services to facilities,
- 7) cost of non-life insurance,
- 8) handling and administrative fees,
- 9) cost of banking services, including: opening and maintaining a sub-account or separate account for the research project, bank fees,
- 10) costs of external audits,
- 11) costs of organising conferences, workshops, seminars, meetings (with the exception of personal costs in points 2.3.3 and 2.3.4),
- 12) costs of subscriptions (with the exception of the cost of data and access to data referred to in point 2.3.6),
- 13) fees for membership in organisations, associations, etc.

All expenses outlined above in points 1-13 may be covered as indirect costs.

2.1. <u>Costs of salaries and NCN scholarships</u>⁵ – include the costs of salaries and related expenditures,⁶ and scholarships.

Salaries may be paid **only to persons employed as members of the research team, i.e. the principal investigator and other investigators in the project.** Project funds may also be used to cover scholarships for doctoral candidates and students involved in the project.

Budget for the salaries and NCN scholarships for members of the research team may include resources for:

- a) *full-time remuneration* i.e. salaries paid pursuant to a full-time contract of employment to the principal investigator in the project and persons employed as post-docs,
- b) additional remuneration for members of the research team,
- c) the NCN scholarships for doctoral candidates and students.

⁵ For a group of entities, the budget for salaries and NCN scholarships is shared by all individual host institutions that form the group of entities.

⁶ The amounts of salaries quoted in the document are gross amounts. The amounts quoted shall include also nonwage labour costs, including social and health insurance contributions and other elements of remuneration, financed by the host institution. These resources shall also cover the additional annual bonus, should the host institution be obliged to pay it.



A research team member may be paid a salary from the project's direct costs only in one of the forms listed above in points a) through c).

2.1.1. Full-time remuneration:

Principal investigators may be paid a salary from the pool allocated for full-time remuneration pursuant to a full-time contract of employment as long as they meet all of the following conditions:

- a) at the time of receiving such remuneration they are not receiving any other remuneration paid from the resources granted as direct costs under NCN calls;
- b) at the time of receiving such remuneration they are not employed pursuant to another contract of employment⁷ nor do they receive a pension from the social security system;
- c) funding for their employment is⁸ PLN 190,000 per annum.

Person at a *post-doc* **type post**⁹ may be paid a salary from the pool allocated for full-time remuneration pursuant to a full-time contract of employment as long as they meet all of the following conditions:

- a) have been selected in an open competition procedure, carried out by a three-person recruitment committee appointed by the head of the project's host institution, composed of the project's principal investigator as its chair and at least two other persons selected by him/her, who have all the necessary scientific or professional qualifications. The assessment of the candidates is carried out pursuant to the criteria outlined in the announcement of the competition, and the results are made public by posting on the website of the project's host institution;
- b) the principal investigator in the project has not been thesis supervisor/auxiliary thesis supervisor of their doctorate;
- c) for a period of two years preceding their employment in the project they have not been employed pursuant to a contract of employment by the host institution where the research project will be carried out;
- d) at the time of receiving such remuneration they are not receiving any other remuneration paid from the resources granted as direct costs under NCN calls;
- e) in the period of receiving the salary they are not employed pursuant to another contract of employment⁵;
- f) funding for their employment⁶ is PLN 120,000 per annum.

The criterion set forth in point b) may be waived for only one person employed at the post-doc type post in the project with a salary paid from the pool allocated for full-time remuneration.

International calls allow for employment of individuals at the post-doc type posts provided that the aggregate time of employment of all persons employed at such posts is no more than twice

⁸ If full-time salary is not received on a continuous basis during the entire course of the project's completion, the total costs budgeted for this purpose should be proportionally reduced.

⁹ A *"Post-doc"* type post is to be understood as a full-time post, planned by the project's principal investigator for a person who has obtained their doctorate degree within 7 years before joining the project. This period does not include career breaks related to maternity leave, adoption leave, paternity leave, parental leave granted in compliance with the Labour Code, periods of maternity benefit or parental benefit, or periods of sickness benefit or rehabilitation benefit granted on account of being unfit to work, including any caused by a health condition requiring physiotherapy. Women may extend the 7-year period by 18 months for every child born or adopted. A woman may choose whichever manner of accounting for career breaks she finds preferable.

the time planned for the project's duration. The minimum duration of an individual employment contract at this post is 6 months.

2.1.2. Additional remuneration:¹⁰

The project funds may be directed toward payment of additional remuneration, which may be used to finance employment pursuant to full- or part-time employment contracts as well as pursuant to civil law contracts. Member of a research team employed pursuant to a contract of employment by a host institution may not receive additional remuneration pursuant to a civil law contract.

When calculating the budget for additional remuneration, the calculation shall exclude from the research team (i.e. principal investigator and other investigators) any persons who in the period of the project's duration are to be paid from the *full-time remuneration* pool of another NCN-funded project, and persons are to receive the NCN scholarships under the project. The number of persons thus determined shall be the basis for the calculation of the budget for additional remuneration.

The amounts set out below serve solely the purpose of calculating the maximum budget for additional remuneration in a given project. The maximum budget for the salary of the principal investigator may not be increased once the project has entered the stage of implementation.

Under international calls, the budget for additional remuneration calculated for each month of the project's implementation, for all investigators, amounts in total to no more than:

- a) should the principal investigator not plan to be employed pursuant to a full-time contract of employment, with salary paid from the pool allocated for full-time remuneration:
 - PLN 6,000 for one person;
 - PLN 7,500 for two persons, of which no more than PLN 6,000 for the principal investigator;
 - PLN 8,500 for three persons, of which no more than PLN 6,000 for the principal investigator;
 - PLN 9,500 for four persons, of which no more than PLN 6,000 for the principal investigator;
 - PLN 10,500 for five or more persons, of which no more than PLN 6,000 for the principal investigator;

Furthermore, if a research team is created by **a group of entities** and is to employ **over 5 people**, the budget for remuneration for investigators may amount to no more than:

- PLN 11,500 for six persons, of which no more than PLN 6,000 for the principal investigator;
- PLN 12,500 for seven or more persons, of which no more than PLN 6,000 for the principal investigator
- b) should the principal investigator plan to be employed pursuant to a full-time contract of employment, with salary paid from the pool allocated for full-time remuneration:
 - PLN 1,500 for one person;
 - PLN 2,500 for two persons;
 - PLN 3,500 for three persons;
 - PLN 4,500 for four or more persons;

Furthermore, if a research team is created by a group of entities and is to employ **over 4 people**, the budget for remuneration for investigators may amount to no more than:

- PLN 5,500 for five persons;
- PLN 6,500 for six or more persons.

2.1.3. NCN Scholarships:

The NCN scholarships¹¹ may be awarded provided that:

- a) they are granted in compliance with the Regulations on awarding scholarships in the NCNfunded research projects, as specified in the NCN Council Resolution No 85/2018 of 26 September 2018;
- b) in the period of receiving the NCN scholarship, the investigator may not receive remuneration from the NCN funds;¹²
- c) the total amount of all NCN scholarships received by one investigator does not exceed PLN 4,500 a month. This amount must not include the doctoral scholarship funded from the NCN resources under the ETIUDA call.

Under international calls, the total monthly budget for NCN scholarships may not exceed PLN 13,500. The amount indicated serves solely the purpose of calculating the maximum budget for scholarships in a given project.

2.2. <u>Costs of research equipment, devices and software 1^{13} – this category includes costs of the research equipment, other devices and software to be purchased or constructed, as necessary to conduct the research tasks in the project.</u>

Research equipment (as defined by the Central Statistical Office) is to be understood as set(s) of testing, measurement and laboratory apparatus[es] of limited application and high technical parameters (usually several orders of magnitude higher than typical apparatus used for production or exploitation purposes), which in accordance with the accounting policies of the host institution constitute the host institution's fixed assets.

Purchase of research equipment may not constitute the main goal of the project.

Other devices – other devices outside the scope of the definition of research equipment, which in accordance with the accounting policies of the host institution constitute the host institution's fixed assets.

Software – software purchased to meet the requirements of the research project, which in accordance with the accounting policies of the host institution constitutes the host institution's intangible assets.

The value of research equipment shall be determined in accordance with the Accounting Law and it includes, among others: costs of transportation, loading and unloading, insurance of the transported goods, installation/assembly, customs and excise duty, and the value of software if it is treated as a component of the research equipment.

2.3. <u>Other direct costs</u> – this category includes costs qualifying neither as "costs of salaries"

¹³ The project's resources may not be used to fund or co-fund the purchase or construction of research equipment and IT infrastructure with a value in excess of PLN 500,000 (Article 365 (2) (b) of the Act on Higher Education and Science of 20 July 2018).

and NCN scholarships" nor "costs of research equipment, devices and software."

2.3.1. Materials and small devices – cost of purchasing materials and consumables for direct use over the course of the project, including, among others:

- raw materials, half-finished products, reagents,
- stationery, office items and supplies,
- small laboratory devices, IT hardware and small office devices (e.g. a computer, licensing costs and software development, printers, scanners, monitors, copiers) and other devices, as long as they are not qualified as tangible or intangible assets according to the accounting policies of the host institution.

2.3.2. Outsourcing: costs of services rendered by third parties (incorporated as well as self-employed individuals), including, among others:

- cost of research services (laboratory analyses, statistical reports, polls, etc.),
- cost of purchasing other specialist services critical to the completion of the research in due form (proofreading, editing, graphics, counselling, monitoring, etc.),
- cost of postal, courier and transport services directly related to the completion of a given research task,
- cost of renting a venue, cost of catering, etc., which are essential to the completion of research tasks that include subjects/respondents.

Persons who are recipients of salaries or scholarships in the project may not be involved in research tasks as subcontractors directly or indirectly (via institutions that employ them).

<u>2.3.3. Business trips</u> – costs of business trips of the members of the research team, including, among others:

- costs of participation in seminars/conferences related to the subject of the research,
- costs of trips (including business trips) critical to the completion of the research, e.g. preliminary archival and library research, fieldwork, etc.

Costs of business trips include:

- daily allowance and reimbursement of travel costs, as set forth by the regulations passed in accordance with art. 77⁵ § 2 of the Polish Labour Code,
- individual insurance,
- conference fees,
- other costs, as long as they are considered justified and essential to the completion of the research, such as: visas, vaccinations, etc.

Long-term expeditions may be eligible if their costs have been calculated in line with the principle of advisability and frugality, based on a solid assessment of their actual costs.

2.3.4. Visits and consultations – costs of individual visits by external collaborators and/or consultants closely connected to the subject of the research, excluding the costs indicated as ineligible above.

The eligible costs in this category are limited to personal costs such as allowances, reimbursement of travel costs and accommodation.

2.3.5. Collective investigators – total cost of gratification for persons carrying out one-time responsibilities (e.g. interviewers) as well as study participants. The minimum number of such investigators is 5 persons. This category does not include technicians and lab managers.

A detailed cost estimate shall be drafted, describing the objective of the expenditure and its total cost, as well as the number of persons receiving benefits, the value of individual benefit and the form of benefit (monetary or material).

<u>2.3.6. Other costs</u> – other costs not included in any of the previous categories, among others:

- costs of purchasing data/databases or access thereto,
- specialist publications/teaching aids,
- costs of publishing the results of research carried out under the project in a journal/ journals of international impact.

The research project may include actions intended to promote it and disseminate its results. Anticipated costs generated by such actions, as long as they meet the conditions of eligibility, shall be entered in the categories *"Costs of salaries and scholarships," "Outsourcing,"* etc., accordingly.

3. <u>Cost eligibility</u> for entities applying for state aid.

If state aid is applied for, the applicant may include in the project only eligible costs, as set out in this annex (with the exception of costs of scholarships) and which are also eligible pursuant to the Regulation of the Minister of Science and Higher Education of 9 September 2015 on the terms and mode of granting state aid via the National Science Centre (Journal of Laws of 2015, item 1381).

Individual items should be grouped as follows:

W – costs of salaries together with non-wage labour costs for persons employed in a research project to the extent in which these salaries are directly connected with the completion of the project (in the case of salaries for collective investigators, *Wz* should be chosen);

A – costs of research equipment and instruments to the extent and for the period in which they are used for the completion of the project; if the research equipment and instruments are not used for the completion of the project over the entire period of use, only depreciation costs corresponding to the period of the project's completion are eligible. Depreciation costs should be calculated based on the applicable accountancy regulations;

G – costs of buildings and land to the extent and for the period in which they are used for the completion of the project; in the case of land – costs of leasing the land and actually incurred capital costs; in the case of buildings, only depreciation costs corresponding to the period of the project's completion are eligible. Depreciation costs should be calculated based on the applicable accountancy regulations;

E – costs of research conducted based on contracts, costs of knowledge and patents purchased or used pursuant to license agreements with external parties on a full competition basis, as well as costs of consultancy and parallel services used solely for the completion of the research project;

Op – other operating costs, including cost of materials, supplies and similar products directly related to the completion of the research project;

O - additional general costs (indirect costs).
