## RESOLUTION NO 88/2019 OF THE COUNCIL OF THE NATIONAL SCIENCE CENTRE

of 12 September 2019

amending the terms and regulations on awarding funding for research tasks funded or co-funded under international calls launched by the National Science Centre and carried out as multilateral collaboration UNISONO

**§**1

Pursuant to Article 21, in conjunction with Article 20 (1) (4) of the Act on the National Science Centre of 30 April 2010 (Journal of Laws of 2019, item 1384), the Council of the National Science Centre hereby amends the terms and regulations on awarding funding for research tasks funded or co-funded under international calls launched by the National Science Centre and carried out as multilateral collaboration UNISONO, adopted pursuant to NCN Council Resolution No 33/2019 of 14 March 2019 as follows:

- 1) the official gazette in §5 (2) in which the uniform text of the Act on the National Science Centre is published shall be amended as follows: "Journal of Laws of 2019, item 1384";
- 2) §13 shall be amended as follows:
  - "§ 13. The person named as the project's principal investigator cannot be a person who on the last day of submitting NCN proposals:
  - a) acts as principal investigator<sup>1</sup> in three or more research projects financed from the NCN resources;
  - b) acts as principal investigator in two research projects financed by the NCN and is named as principal investigator in a proposal under evaluation;
  - c) acts as principal investigator in a research project financed by the NCN and is named as principal investigator in two proposals under evaluation;
  - d) is named as principal investigator in three proposals under evaluation.";
- 3) in §18
  - the following new paragraph shall be added before §8 and shall become §8:
    - "8) information on the data management plan concerning data generated or used in the course of a research project, as required by the proposal (in English)";
  - paragraph 8 shall become paragraph 9 and shall read as follows:
    - "9) information on the ethical aspects of the project, including any consents, opinions, permits and/or approvals necessary to carry out the project in compliance with generally applicable laws and best practices adopted for a specific academic discipline, as required by the proposal (*in English*);
  - paragraph 9 shall become paragraph 10;
  - paragraph 10 shall become paragraph 11;
- paragraph 11 shall become paragraph 12;
- paragraph 12 shall become paragraph 13;
- paragraph 13 shall become paragraph 14;
- paragraph 14 shall become paragraph 15 and shall read as follows:
  - "15) administrative declarations by the principal investigator and host institution, as required by the proposal.";

<sup>&</sup>lt;sup>1</sup> Acting as principal investigator applies to the period from the date of the funding agreement until the day of submitting the final report on the completion of the research project.

4) new annex "Costs in research projects funded by the National Science Centre under international calls carried out as multilateral collaboration Unisono" shall be introduced.

§ 2

The terms and regulations on awarding funding for research tasks funded or co-funded under international calls launched by the National Science Centre and carried out as multilateral collaboration UNISONO, as amended according to §1, shall be annexed hereto.
