II. CONTRACT AWARDING PROCEDURE

The contract pertains to social services listed in the Attachment XIV to the directive 2014/24/EU with the value in PLN below the equivalent of EUR 750,000. The procedure is being carried out under Article 1380 items 2-4 of the Public Procurement Law Act of 29 January 2004 (consolidated text Journal of Laws 2018.1986, as amended), hereinafter also referred to as "PPL Act".

III. SUBJECT OF THE CONTRACT

- 1. The subject of the tender is the development and delivery of an IdeaLab workshop in the frames of the Basic Research Programme within the EEA Financial Mechanism and Norwegian Financial Mechanism 2014-2021, operated by the National Science Centre (hereinafter: Contracting Authority). The workshop shall be carried out according to the 'sandpit' method developed by the UK Engineering and Physical Sciences Research Council and used by the Research Council of Norway under the 'idélab' name. The aim of the workshop is to prepare workshop participants to develop ground-breaking research and innovation projects. Creative and innovative techniques shall be used during the workshop to enhance the potential of the group and to encourage the participants to think outside the box about the challenges outlined in the call. The workshop will provide an unconventional arena for participants, which shall increase their effectiveness in the development of research ideas. Research project ideas developed during the workshop will be evaluated by experts.
